SURFACE PREPARATION

General:

All surfaces must be firm, dry and cleaned free of loose paint, dust, dirt, oil, grease, wax, chalk, rust, mildew or any other contamination or condition that would adversely affect the performance of the coating. Remove mill-glaze by lightly sanding†. †See warning for existing lead-based paint under Precautions.

New Surfaces:

Apply first coat, let dry thoroughly, and lightly sand until surface and finish is smooth. Apply successive coats, progressively using finer sandpaper until desired look is achieved. If stain is used on wood prior to finishing, allow stain to dry 24 hours.

Previously Painted Surfaces:

Follow general surface preparation guidelines. Remove loose or failing paint and spot prime bare areas or entire surface with the appropriate primer. Hard, glossy surfaces may require sanding and/or a bonding primer. Always apply a test patch on the surface to ensure compatibility.

To avoid lap marks, maintain a wet edge. Keep product from freezing.
